## Aldworth's Battle at Celtic – Easy as ABC

Huge strides were made this month in the battle against the sectarian violence which has blighted Scotland's top level football for years. Celtic FC, one of the two clubs worst afflicted by this plight, has instituted a range of measures designed to stamp out the issue which has damaged the clubs European reputation, and played a part in the club's declining fortunes.

Substantial resources have been invested in new measures to combat the disruptive elements, ranging from enhanced CCTV systems to increased security. Celtic have also found considerable success with the new "Shop a Bigot" system, where fans are rewarded for providing information which leads to a successful conviction of those responsible for inciting hatred.

Since the scheme's establishment, the state of the art CCTV cameras have been able to identify over thirty offenders, all of whom

were picked up leaving the stadium. This represents a significant improvement on previous processes, which have usually taken weeks or months to produce results.
